## What is this product?

Type	Ambienta X ICAV is a Open-ended Investment Company (OEIC) composed of several separate sub-funds organized under the laws of the Ireland
Term	The Fund has no minimum fixed term. Termination of the Fund is only possible in those cases expressly provided for in the Prospectus or Supplement of the Fund.
Objectives	The investment objective of the Fund is to generate attractive risk-adjusted returns by investing primarily in environmentally sustainable ("ES") investments. It is intended that the Fund will seek to achieve its investment objective by investing primarily (but not exclusively) in equities and equity-related or linked securities of companies worldwide which are exposed to environmental trends and are considered sustainable investments. ES investments are those investments which contribute to an environmental sustainable objective, provided that such investments do not significantly harm any of those objectives and that investee companies follow good governance practices. As a result, the Manager seeks to invest in the securities of companies or issuers exposed to ES trends which have a commercial purpose of solving environmental problems. The Fund may invest in companies of all market capitalisations, but will generally invest in medium capitalisation companies. For these purposes, the Manager considers medium sized companies to be those with market capitalisations from \$500 million to \$10 billion at the time of purchase. The Fund is considered to be actively managed in reference to the STOXX Europe 600 Index (Bloomberg: "SXXP Index"), and this benchmark is used in the calculation of performance fees.

## What are the risks and what could I get in return?

### Summary Risk Indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 4 out of 7, which is a medium risk class. This classification takes into consideration two elements: 1) the market risk - that rates the potential losses from future performance at a medium level; and 2) the credit risk which estimates that poor market conditions are very unlikely to impact our capacity to pay you. This product does not include any protection from future market performance so you could lose some or all of your investment. **Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.**
