Ambienta holds the first close of its sustainable credit fund

- Ambienta Sustainable Credit Opportunities has held a first close, already reaching half its initial target.
- Commitments secured from a broad range of thought leading investors across Europe and the US, including foundations, pension funds and family offices.
- The strategy, with an exclusive focus on backing environmental champions, will leverage the team's deep experience in corporate credit with Ambienta's environmental sustainability expertise built over 17 years.

Ambienta SGR SpA ("Ambienta" or the "Firm"), one of Europe's leading and largest asset managers solely focused on environmental sustainability, today announced the first closing of Ambienta Sustainable Credit Opportunities ("Ambienta Credit") reaching already around half of its €500m target.

Ambienta Credit was launched as a natural evolution of the Firm's strategy and builds on Ambienta's fundamental sustainability thesis founded on the belief that environmental sustainability is the largest macro trend in history and represents one of the greatest investment opportunities of this century. More importantly, with the launch of Ambienta Credit, the firm adds a third strategy dedicated exclusively to environmental champions to its platform. In line with Ambienta's Private Equity and Public Equity offerings, Ambienta credit products are rated Article 9 under the Sustainable Finance Disclosure Regulation ("SFDR").

Ambienta Credit will partner with and support the development of European mid-market companies, exclusively focusing on environmental champions whose products or services use resources more efficiently or reduce pollution, and who are underpinned by growing end markets and strong defensive characteristics. In addition to the credit team, led by Ran Landmann (Partner and Chief Investment Officer) and Nishan Srinivasan (Partner and Head of Origination), Ambienta Credit benefits from the support of the broader platform and in particular the dedicated Sustainability and Strategy team – a team of engineers - who analyse the science and business dynamics of the effects of environmental themes across sectors and value chains.

The delivery of the strategy is anchored by the award-winning proprietary methodology behind the success of Ambienta Private Equity: the *Environmental Impact Analysis* ("EIA"), which measures the positive environmental impact of a target company, and the *ESG in Action* program, which assesses and improves the ESG profile of portfolio companies.

Ambienta is a leading European environmental sustainability investor across private equity, public markets and private credit. Operating out of Milan, London, Paris and Munich, Ambienta manages over €3.0 billion in assets with a focus on investing in private and public companies driven by environmental mega trends whose products or services improve Resource Efficiency or Pollution Control. In private equity Ambienta has completed 68 investments to date.
