What is this product?

Туре	Ambienta X ICAV is a Open-ended Investment Company (OEIC) composed of several separate sub-funds organized under the laws of the Ireland
Term	The Fund has no minimum fixed term. Termination of the Fund is only possible in those cases expressly provided for in the Prospectus or Supplement of the Fund.
Objectives	The investment objective of the Fund is to generate attractive risk-adjusted returns by investing primarily in environmentally sustainable ("ES") investments. It is intended that the Fund will seek to achieve its investment objective by investing primarily (but not exclusively) in equities and equity-related or linked securities of companies worldwide which are exposed to environmental trends and are considered sustainable investments. ES investments are those investments which contribute to an environmental sustainable objective, provided that such investments do not significantly harm any of those objectives and that investee companies follow good governance practices. As a result, the Manager seeks to invest in the securities of companies or issuers exposed to ES trends which have a commercial purpose of solving environmental problems. The Fund may invest in companies of all market capitalisations, but will generally invest in medium capitalisation companies. For these purposes, the Manager considered to be actively managed in reference to the STOXX Europe 600 Index (Bloomberg: "SXXP Index"), and this benchmark is used in the calculation of performance fees.

The summary risk indicator is a guide to the level of risk of this product compared to other products. This classification takes into consideration two elements: 1) the market risk - that rates the potential losses from future performance at a medium level; and 2) the
