Objectives

Depositary

The investment objective of the Fund is to generate attractive risk-adjusted absolute returns by investing primarily in environmentally sustainable ("ES") investments. It is intended that the Fund will seek to achieve its investment objective by investing primarily (but not exclusively) in equities and equity-related or linked securities of companies worldwide which are exposed to environmental trends and are considered sustainable investments. ES investments are those investments which contribute to an environmental sustainable objective, provided that such investments do not significantly harm any of those objectives and that investee companies follow good governance practices. As a result, the Manager seeks to invest in the securities of companies or issuers exposed to ES trends which have a commercial purpose of solving environmental problems. The Fund is considered to be actively managed in reference to the STOXX Europe 600 Index (Bloomberg: "SXXP Index"), and this benchmark is used in the calculation of performance fees.
